


General Visitor Rules



STEZKA KORUNAMI STROMŮ (Treetop Walkway) s.r.o.

All visitors are required to acquaint themselves with the General Visitor Rules before entering the area of the Treetop Walkway and the Children's Nature Park and follow the rules.

● Entry to the Treetop Walkway is only possible within opening hours and with a valid ticket. ● Children younger than 12 years of age are allowed to access the walkway only when accompanied by an adult. ● Adults assume full responsibility for the safety of their children. ● Entry to the Treetop Walkway as well as its adrenaline stops and their use are at the own risk of visitors. ● For the safety reasons, adrenaline stops are not allowed to be used by more than one person at a time. ● The visitors are required to report every injury suffered at the Treetop Walkway or in the Children's Nature Park without delay to the Treetop Walkway cash desk officer. The Treetop Walkway operator is not liable for injuries suffered by a visitor as a result of the visitor's neglect of carefulness or as a result of the negligence of persons, who are responsible for those under their supervision. ● The Treetop Walkway operator is not liable for loss of items left behind in the Treetop Walkway area including the areas of the Children's Nature Park and sand playground. ● The Treetop Walkway fire exits marked  can only be used by visitors in case of fire or by order of the operator. In using the fire exits, the visitors are required to follow the operator's and firefighters' instructions.

Treetop Walkway visitors are strictly forbidden to:

● stay in the area outside of the opening hours; ● enter the Treetop Walkway with pets (pets can wait at the entry in specially designed compartments where our visitors can leave them safely while enjoying their visit); ● enter the Treetop Walkway on in-line skates, scooters, bikes or ski boots; ● enter restricted areas "for staff only"; ● lean over the banister; ● throw any items off the Treetop Walkway and observation tower; ● dispose of any rubbish beyond the designated area; ● smoke, start fires or use open flames; ● enter the Treetop Walkway under the influence of alcohol, narcotics or other intoxicating substances; ● consume alcoholic beverages or intoxicating substances at the Treetop Walkway; ● use fire exits without authorization; ● bring guns of any kind, or items which can be used as weapons. ● Employees of the operator have the right to ask a person to leave the area, or to file a legal complaint in the event of unlawful conduct or any breach of regulations (namely these General Visitor Rules). ● In the event of a sudden change in weather (such as a thunderstorm or strong winds), the visitors must follow the instructions given by employees of the operator and immediately leave the Treetop Walkway area. ● The toboggan run without adult supervision is only allowed for children older than 6 years of age. Visitors can only ride using specially designed mats. Only one person can ride at a time. ● The toboggan run will be closed for safety reasons in bad weather conditions. ● Visitors should bear in mind and they hereby give their consent to that video and audio recordings may be taken at the Treetop Walkway for the purpose of promotional events and to the publishing of photographs taken at the Treetop Walkway in which they may feature. Such pictures will be published on the webpages: www.stezkakorunamistromu.cz and www.facebook.com/stezkakorunamistromu or possibly otherwise used or spread for promotional purposes. In case of the visitors' disapproval to taking pictures or their possible use, they are required to express their disapproval in writing before they enter the Treetop Walkway area. ● We would like to inform our guests visiting the Treetop Walkway that the cash desk premises are covered by a CCTV monitoring system and the camera recording shall only be used in the event of loss, theft or damage to the visitor's or the operator's property or in any other similar event. In such cases, the camera recording shall be handed over to the relevant state authorities, particularly the Police of the Czech Republic. ● For more details about visitors' rights in accordance with Act No. 101/2000 Coll. on Personal Data Protection, as amended, please see www.oou.cz

Children's Nature Park:

● The visitor is required, before entering the area, to get acquainted with the respective provisions contained in the General Visitor Rules of the Treetop Walkway and to observe these provisions as well as those contained in the extract from these Rules available on the information board installed directly by the area of the Children's Nature Park. ● The Children's Park and the sandpit in the area of the Treetop Walkway as well as play elements installed at these attractions by the operator are intended for adults and children over 3 years of age. ● In using play attractions in the Children's Nature Park, it is necessary to observe obvious construction features, namely carrying capacity, and to respect own physical and health conditions. Physically handicapped persons are required to judge their entry to the Children's Nature Park with regard to the type and level of handicap. ● In using play attractions in the Children's Nature Park, it is strictly forbidden to consume food or beverages, chew chewing gum or have other items in mouth. ● Responsible for safety of children in using play attractions are adults who accompany the children in the area of the Treetop Walkway resort. The Treetop Walkway operator is not liable for an injury to health or life, if such injury results in particularly from the failure to observe the provisions of the General Visitor Rules or the visitor's neglect of required carefulness or overestimate of physical capabilities of the visitor or in connection with the neglect of supervision over a minor or handicapped person. ● The Children's Nature Park and sandpit can only be entered in suitable clothes and shoes. For safety reasons, it is recommendable not to enter the area with wristwatch and jewel and to tie long hair before using play attractions. The operator is not liable for loss of or damage to clothes, shoes, wristwatch, jewel or other parts of clothes. ● The Children's Nature Park is not a conventional children's playground. In using play attractions, the persons need to be spotted. Every play element can only be used by one person at a time. ● Smoking is strictly forbidden in the area of the Children's Nature Park, as well as it is forbidden to kindle a fire or move with a fire.

● Rights and duties of the visitors and of the operator not covered by these General Visitor Rules are governed especially by Rule 89/2012 Coll., Civil Code, as amended, and the current legislation of the Czech Republic.
